TERMS & CONDITIONS OF SALE

1. All goods are supplied by Tradeglass (the 'seller') to you (the 'buyer') on the following terms and no person in the employment of Tradeglass or acting or purporting to act as its agents has any authority to supply goods or to accept orders for the goods on any other terms or to vary them in any way whatsoever. Acceptance of the goods by the buyer shall be conclusive proof before any court that these terms apply to that contract for the sale of goods. English Law shall govern these terms and all contracts made under them and all disputes heard by English courts.
2. **GUARANTEE:** - Goods are not tested or sold as fit for any purpose and any term warranty or conditions express implied or statutory to the contrary is excluded. In no circumstances whatsoever shall the sellers liability (in contract tort or otherwise) to the buyer arising under out of or in connection with this contract or the goods supplied hereunder exceed the invoice price of the particular pieces concerned: and the seller shall be under no liability for loss or damage howsoever arising caused by circumstances outside his control. This provision shall not apply to consumer transactions to the extent to which it would be by virtue of the unfair contract terms act I 1977, be void. Work carried out on customer's own glass is done entirely at customer's risk.
3. **CREDIT TERMS & OVERDUE ACCOUNTS**
 - (I) All first orders are Pro Forma – payment can be made via MasterCard, Visa, Switch, Delta, Electron, Maestro, – cash and/or sterling cheques. .
 - (II) Tradeglass credit account terms for UK mainland accounts are Nett 28 days from date of invoice. No extended credit unless authorised in writing. Accounts opened only on approval of two trade references and one bank reference at a cost to the buyer.
 - (III) Tradeglass reserves the right to charge interest and compensation at the going rate on invoices outstanding outside the 28 days trading terms.
4. **DELIVERIES:** - No responsibility can be accepted by Tradeglass in respect of non delivery of goods until the buyer notifies Tradeglass within 2 working days from receipt of goods.
5. If consignments are delivered damaged or with part contents missing, they must be signed for accordingly and notification sent in writing to Tradeglass within 2 working days of delivery. Except as stated in these conditions, no claim of any kind whatsoever will be accepted unless the claim is received by Tradeglass in writing within 28 days from date of invoice.
6. **TITLE:** - The property in the goods shall not pass to the buyer until the buyer has paid 'all monies' retention of the title to the seller the whole price thereof. If, notwithstanding that the property in the goods had not passed to the buyer, the buyer shall sell the goods in such manner as to pass to a third party a valid title to the goods, the buyer shall hold the proceeds of such sale on trust for the seller. The buyer agrees that prior to the payment of the whole price of the goods the seller may at any time enter upon the buyers premises and remover the goods there from and prior to such payment the buyer shall keep the foods separate and identifiable for this purpose. Nothing herein shall constitute the buyer, the agent of the seller for the purpose of any such sub-sale. Notwithstanding that property in the goods shall not pass to the buyer save as provided above, the goods shall be at risk of the buyer from the time of collation by the delivery to him of the goods.
7. **REPRESENTED CHEQUES:** - Returned / dishonoured cheques will be charged at the banks prevailing administrative rate.
